The **Senior Director, Health Promotion, Chronic Disease and Injury Prevention, BC Centre for Disease Control** reports to the Executive Director, BCCDC Operations and Chronic Disease Prevention and is a member of the BCCDC Senior Executive Leadership Team. The portfolio has a provincial mandate and is responsible and accountable for the leadership and ongoing development, implementation and coordination of Provincial non-communicable disease and injury prevention programs under the expanding Provincial mandate for the BC Centre for Disease Control.

This role will work with multiple stakeholders including the Ministry of Health, First Nations Health Authority, PHSA and the Regional Health Authorities' leaders across stakeholder groups within health authorities and the Ministry of Health.

The Senior Director partners with the Executive Team, in close collaboration with the Senior Administrative Leadership to ensure integration of chronic disease and injury prevention into a broader BCCDC mandate. This includes directing the strategic development, implementation and evaluation of the Public Health surveillance program for chronic disease prevention and health promotion, and ensuring administrative/operational efficiencies and improvements across BCCDC and the Province.

The Senior Director plays a vital role in the development and implementation of plans, goals, objectives for the integration and building of the Province non-communicable disease and injury prevention programs, including the integration of the PHSA Population & Public Health program, and the development of functions, standards, processes and structures to support and delivery the vision of the programs into the future.

This role requires an extraordinary individual who truly embodies the essences of leadership, and inspires and motivates teams with a passion and drive to deliver excellence in public health. The successful incumbent:

- Has demonstrated their ability to influence and guide staff toward a vision while maintaining motivation and effectiveness.
- Is an astute critical thinker with a history of executing the development, implementation and evaluation of strategic and operational plans.
- Is able to demonstrate quality improvement change management skills.
- Has a level of education, training and experience equivalent to a Master's Degree with specific education in areas of administration/leadership or health care, and a minimum of eight (8) years of experience in progressively senior leadership roles.
